TRASH PICK-UP RULES:

YARD WASTE, GARBAGE, OLD LUMBER, BUILDING MATERIALS AND METALS MUST BE SEPARATED INTO PILES BEFORE THE CITY OF SHERIDAN CAN PICK UP THE DIFFERENT MATERIALS.

DO NOT MIX!! IT TAKES TOO LONG FOR SANITATION WORKERS TO SEPARATE.

OUR WORKERS COMP INSURANCE WILL NOT ALLOW OUR EMPLOYEES TO PICK UP LOOSE TRASH AND GARBAGE. PLEASE BAG, BOX OR HAVE IN A GARBAGE CAN.

PLEASE DO NOT SET OUT PAINT CANS WITH LIDS ON THEM OR ANY OTHER CANS WITH LIQUIDS INSIDE. IF YOU HAVE FULL OR PARTIAL CANS OF PAINT, TAKE THE LIDS OFF AND ALLOW CONTENTS TO DRY BEFORE PLACING AT THE STREET TO BE PICKED UP. DO NOT PUT LIDS BACK ON CANS.

THE CITY OF SHERIDAN DOES NOT PICK UP ANY TYPE OF ROOFING MATERIALS. RESIDENTS MUST DISPOSE OF ROOFING MATERIALS THEMSELVES. THE COUNTY TRANSFER STATION WILL ALLOW INDIVIDUALS TO BRING LIMITED AMOUNTS TO THE COUNTY TRANSFER STATION. WE WOULD SUGGEST THAT YOU CALL BEFORE LOADING AND TRANSPORTING TO THE TRANSFER STATION. THE PHONE NUMBER FOR GRANT COUNTY SOLID WASTE IS 942-2740. THE TRANSFER STATION IS LOCATED ON SOUTH ROSE STREET NEAR THE CITY OF SHERIDAN BASEBALL/SOFTBALL COMPLEX.

RESIDENTS ARE LIMITED TO ONE FULL TRUCKLOAD OF YARDWASTE AND TREE LIMBS PER YEAR. IF YOU CONTRACT TO HAVE TREES AND LIMBS CUT, YOU SHOULD ALSO CONTRACT WITH THE CONTRACTOR TO HAUL OFF THE DEBRIS. THE SANITATION DEPARTMENT CANNOT PICK UP AND DISPOSE OF ANYTHING SIX INCHES (6") OR LARGER IN DIAMETER. THE MAXIMUM LENGTH THAT WE WILL PICK-UP IS SIX FEET (6'). LIMBS AND BRUSH MUST BE STACKED OR PILED PARALLEL WITH THE STREET. THIS ALLOWS BRUSH AND LIMBS TO BE PICKED-UP AND LOADED IN LESS TIME.

OUR EMPLOYEES SAFETY IN LOADING IS MOST IMPORTANT. DO NOT PLACE ITEMS TO BE PICKED UP IF WE CANNOT GET TO THEM SAFELY. AS IT HAS ALWAYS BEEN, WE ARE RESTRICTED BY STATE LAW FROM GOING ONTO PRIVATE PROPERTY TO PICK-UP ANYTHING.
